

3.02.1 ANNUAL DUES AND APPLICATION FEESIssue/Background:

In 2015, the fiscal year of the College changed in anticipation of a merger with CAPF. Several bylaws are dependent on the fiscal year including the effects on membership payment and arrear accounts. Upon reviewing the bylaws under Article 3 Memberships, 3.02.1, Council has agreed that this article must be changed to reflect the prorated dues based on the new fiscal year.

- Whereas ... the “College” is committed to good governance.
- Whereas ... the “College” has a new fiscal year and has bylaws influenced by the fiscal year.
- Whereas ... the “College” must align all bylaws to recognize the new fiscal year.
- Whereas ... the “College” provides for discounted membership dues based on prorated basis.
- This special resolution is an amendment to the bylaw and requires a vote of 2/3 of the voting members to be changed

The existing wording of article 3 Membership, 3.02.1 is as follows:
